There is only one form of tax exemption acceptable for the State of Arizona Department, of Revenue: Arizona Form 5000A (found here: https://www.azdor.gov/Portals/0/ADOR-forms/10300/10316_f.pdf). IF YOU ARE FROM A STATE OTHER THAN ARIZONA, PLEASE DO NOT SEND IN YOUR HOME STATE RESALE CERTIFICATE – IT WILL NOT BE ACCEPTED.

Be sure to completely fill in, sign and date the form. Any form not correctly filled out will not be accepted. Please hand the form in at time of payment, or fax form to 818-933-0782.

FOR THOSE IN THE BUSINESS OF MANUFACTURE:

There is only one form of tax exemption acceptable for the State of Arizona Department, of Revenue: Arizona Form 5000 (found here: <http://www.montroy.com/fx/assets/tax/az.pdf>).On Form 5000, please fill out the "Purchaser's Name and Address," "Check Applicable Box" and "Transactions with a Business" Section. For the latter section, fill out every line you can. If you have no tax id number, write "manufacturer" on the "if no license number, provide reason" line. In the box marked "Reason for Exemption" check box #17, and then on the sub-line, check the box marked "Manufacturing, processing or fabricating." Be sure to sign and date the second page. Any form not correctly filled out will not be accepted. Please hand the form in at time of payment, or fax form to 818-933-0782.
