If you make a wire transfer to us, or obtain a cashiers' check, without including the tax and before giving us the required documents, you will not be allowed to remove any equipment until the situation is corrected. Sales tax will be remitted about 21 days after the auction date. If you do not get us the completed tax exemption form within 21 days, steps will not be taken to retrieve your sales tax for you.
